

**Daily situation update of food surveillance on food imported from Japan  
(As of 7 January 2025 12:00 noon)**

In view of Japan's discharge of nuclear-contaminated water since 24 August 2023, to enhance transparency, the Centre for Food Safety (CFS) of the Food and Environmental Hygiene Department reports the food surveillance results of imported Japanese food on CFS's website on every working day starting from the same day.
