Recalled products: all sizes of fresh American cucumbers grown by Agrotato, S.A. de C.V. in Sonora, Mexico.

- Brands: SunFed Produce, Baloian Farms, Russ Davis
- Sold by importers between 12 October 2024 and 26 November 2024 (companies who received recalled cucumbers from importers could have sold recalled cucumbers past 26 November 2024)
- For retailers and distributors: packaged in bulk cardboard containers labeled with the SunFed or Pamela label, in a generic white box or black plastic crate with a sticker that says Agrotato, S.A. de C.V, or in clear plastic packages of various sizes with a 7-digit lot code beginning with "X"
- For consumers: recalled cucumbers may have a sticker that says "SunFed Mexico" or are packaged in a clear PamPak branded bag of 6 individual cucumbers with UPC 8 2540107010 6
- Russ Davis products containing recalled cucumbers:

the affected products.

- Acquisition of the products through online purchase or international travel cannot be excluded.
- Consumers should discard the products and not consume them.
- CFS will remain vigilant and monitor for any new development and take appropriate actions when necessary.
- Investigation by CFS is ongoing.
- Salmonella infection may cause fever and gastrointestinal upset such as abdominal pain and diarrhoea. People with lowered immunity such as infants and the elderly could present with more severe and even life-threatening infection.
