#### **Heading**

The US Food and Drug Administration (FDA) and the Centers for Disease Control and Prevention (CDC) – Notices regarding additional recall of cucumbers or food products containing recalled cucumbers by F&S Fresh Foods, Hardie's Fresh Foods and Fresh Creative Foods to an outbreak of Salmonella Typhimurium infections linked to American/slicer cucumbers grown by Agrotato, S.A. de C.V. in Sonora, Mexico.

### The incident

The US FDA and the CDC issued notices regarding additional recall of cucumbers or food products containing recalled cucumbers by F&S Fresh Foods, Hardie's Fresh Foods and Fresh Creative Foods due to an outbreak of *Salmonella* Typhimurium infections linked to American/slicer cucumbers grown by Agrotato, S.A. de C.V. in Sonora, Mexico.

### Position of CFS

- Information on product distribution outside the US is not available from the websites of the US FDA. The Centre for Food Safety (CFS) is investigating whether the affected products have been imported to Hong Kong and is contacting the relevant authority for further information. Preliminary investigation did not identify local sale or import of the affected products.
- Acquisition of the products through online purchase or international travel cannot be excluded.
- Consumers should discard the products and not consume them.
- CFS will remain vigilant and monitor for any new development and take appropriate actions when necessary.

- Investigation by CFS is ongoing.
- Salmonella infection may cause fever and gastrointestinal upset such as abdominal pain and diarrhoea. People with lowered immunity such as infants and the elderly could present with more severe and even life-threatening infection.
