<b>The incident</b>	<p>Rappel Conso of France issued notices regarding recall of Fleur Pré and Jean Perrin brands Morbier cheese products made from raw milk produced by Perrin-Vermot in France due to possible contamination of Shiga toxin-producing <i>Escherichia coli</i> (STEC).</p> <p>These products were marketed between November 12, 2024 and January 24, 2025 by the Perrin-Vermot cheese dairy.</p> <p>The producer of these cheeses has proceeded to the withdrawal and recall of certain batches of Morbiers, in wheels, portions, slices or cheese platters. 	<p>contacting the relevant authority for further information.</p> <ul style="list-style-type: none"><li>• Acquisition of the products through online purchase or international travel cannot be excluded.</li><li>• Consumers should discard the products and not consume them.</li><li>• CFS will remain vigilant and monitor for any new development and take appropriate actions when necessary.</li><li>• Investigation by CFS is ongoing.</li><li>• Some strains of <i>E. coli</i> can cause diseases through the production of a toxin called Shiga toxin. These strains are called STEC. STEC infection is transmitted by faecal-oral route through contaminated food and water, or direct contact with STEC carrying animals. Moreover, due to poor personal hygiene, person-to-person transmission of this pathogen is possible through oral-faecal route. Symptoms of STEC infection include abdominal pain and watery diarrhoea that may in some cases progress to bloody diarrhoea. Fever and vomiting may also occur. Intestinal bleeding and serious complications such as haemolytic uraemic syndrome may also develop in some people. <i>E. coli</i>, including STEC, cannot survive under high temperature and can be killed by thorough cooking.</li></ul>
<b>Additional information</b>	<ul style="list-style-type: none"><li>• The CFS issued a press release to urge public not to consume a batch of French raw milk cheese Perrin Vermot brand MORBIER LAIT CRU DE SCEY AOP 7KG MEULE imported into Hong Kong which was suspected to be contaminated with STEC and the importer has initiated a recall.
